Ways to Give

Impact Funds

Greatest Need - helps unlock the potential that slumbers in every child by providing unrestricted donations with the most flexibility to determine how/where resources are used to awaken talents and ignite each child's power to find and follow their best path so that they can flourish.

Building Self Sufficiency - counseling, educational enrichment, vocational training and workforce development for single and parenting youth, ages 17 - 24, who are homeless or aging out of foster care.

Educational Support - supporting academic and career success for children in foster care and those without family support systems.

Safe Homes & Strong Families - counseling, guidance and support for children in families and for foster children in family like settings.

Healing Children - specialized therapy to help victims of sexual, physical, emotional abuse, domestic violence and other traumas in addition to those learning to live productively with behavioral health issues.

Community Education - offers training in best practice clinical approaches ranging from the prevention of child sexual abuse and bullying to trauma focused care, customer service and non-profit business practices.

LGBTQ - Assists children, youth and families that are Lesbian, Gay, Bisexual, Transgender and Questioning. Services include housing, counseling, and basic needs.

Holidays & Activities - Ensures children, youth and families are able to celebrate holidays throughout the year. Includes birthdays, cultural enrichment and community activities and events.
